

SOFTWARE LICENSE AGREEMENT

- Software or program(s) means the enclosed Licensor software program(s) / options / FPGA IP
 and the accompanying materials corresponding to the configuration you have licensed, and
 that are owned by Licensor or its suppliers and are protected by law.
 - a. Proc means Proc board(s) and systems supplied by Gidel.
- 2. License: You have the non-exclusive right to use the enclosed Licensed Program USING ONLY GIDEL PROC BOARD(S) OR SYSTEM(S) by the manner provided below.
- 3. You may not distribute any of the headers or source files, which are included in by the Software package, especially, but not limited to, the proc.h file. You may not modify, copy, duplicate, reproduce, license or sub-license the Software.
- 4. You and your end customers may use Proc Boards and systems with the driver that was generated by the Licensed Software. You may distribute the relevant *.DLL or *.VXD or *.SYS files with the Proc board(s) or system(s), for the purpose of Proc driver only, as part of your product.
- 5. No User may alter or modify the software or the accompanying written materials.
- 6. You may make printed copies of the written materials only for the purpose of developing your application over Gidel Proc boards and systems.
- 7. You may not use, copy, merge, transfer, decompile, disassemble, or in any way try to access the source code or reverse-engineer the Licensed Program, or any copy or portion of it, unless provided for in this agreement.
- 8. Ownership of the Licensed Program: The licensed Program is owned and copyrighted by Gidel Ltd. You may not engage in any activity being in violation of the copyright laws. You will make your best efforts to prevent any unauthorized copying or use of the Licensed Program, including manuals diagrams and drawings.
- 9. Warranty: Gidel warrants to the original licensee that magnetic or optical media on which the Program resides, will be free of defects in material under normal usage and service for a period of ninety (90) days from the date of delivery. All replacement software media will be provided only upon prepaid return of the original media.
